# SWIMMING POOL CHANGES: HOW THEY AFFECT YOU

REGULATIONS which control private swimming pools were amended in November.

The most significant change to the previous regulations is that a fence between doorways from the residence and the pool area is not compulsory.

A new Australian standard AS1926.1-1993 has been adopted as the technical reference.

These changes will only apply to new pools being installed after November 12, 1993. Existing pools will NOT have to be altered to comply with new regulations.

Suitable barriers to restrict access to the pool by children under the age of five years may include the use of existing boundary fences and buildings, provided that a minimum height of 1200mm is maintained.

No climbing assistance within a 1200mm radius from the top of the fence, or any hand/ foot holds to assist climbing, can be allowed.

Access to the pool area via the residence, garages, sheds etc must have self-closing and latching doors, with the latches at least 1500mm above the floor. They must not open towards the pool area. The same rule applies to gates in pool fencing.

Windows must be protected by security grilles or be restricted to 100mm openings.

As the technical rules are complex, assistance can be obtained from Council's building office.

To comply with State government legislation, all private swimming pools must be reassessed for safety before July 1996. A charge for this operation will be made against all pool owners.

The assessment is planned to begin during 1995.

# PENSIONERS' RATES CONCESSION

ELIGIBLE pensioners may be entitled to a rebate on their Council rates (but not other charges) of up to 50 per cent.

To be entitled to a rates concession for any particular rating year you must, at the 1st of July of that rating year, have:

- \* been the holder of a Pensioner Concession Card
- \* occupied the property as your ordinary place of residence; and
- \* been the owner of the property or have had a relevant interest in the property.

Your land may be considered to be the ordinary place of residence notwithstanding that you no longer reside there due to illhealth, frailty or other causes not within your control.

Although you may not be an owner of the property, nor have a relevant interest in the land, you may receive a rebate (deferment option not available) if your spouse or exspouse is the sole owner of the land and deserted the family, leaving you responsible for payment of rates.

Please note that you will have to provide full details of the circumstances in each of the above three (may) situations if Council is to allow you to register.

The concession available is:

- \* A 50 per cent rebate on rates or deferment of rates (but not other charges) to eligible pensioners who solely own their residence and occupy the premises with other people.
- \* a proportionate rebate up to 50 per cent to eligible pensioners who partly own the residence they occupy.

To receive the concession you must register with Council by:

- \* completing and lodging an application form with Council (forms are available from Council offices)
- \* produce with the application form your Pensioner Concession Card.

It is important to note that you can only receive a rates concession in a rating year if you have registered at the "registration date". This date is thirty five (35) days from the issue of the rate notice ie the date shown as the "Last Day to Pay" on your rate notice.

In other words, you can pay your rates then register for a concession and still qualify for a rates rebate provided that you were registered before the registration date and were an eligible pens. There as set out above on July 1 of the rating year.

However, if you register after the "registration date" you will not be able to obtain a concession until the following rating year.

After registration you are required to notify Council:

- \* if you cease to hold a Pensioner Concession Card
- \* if you cease to occupy the property as your ordinary place of residence
- \* if your interest or proportion of ownership in the land changes; or
- if the land ceases to belong to you.

This requirement also applies to pensioners already registered with Council.

### LIBRARY SHELVING FOR TOTS



NEW shelving has been installed in the junior kindergarten area of Spearwood Public Library. This section caters for junior members from birth to seven or eight years of age.

Two shelves have been built along walls of the J-K area (above) at a height which allows small children to reach display books. A continuous shelf at floor level provides storage for books in author order.

The flat shelf on top of the unit provides additional display space as well as an area for videos and cassette storage.

# BIG RESIDENTIAL GROWTH PLANNED FOR THE DISTRICT

AS a consequence of the growth of the area, the State Government and the Department of Urban Development has identified large tracts of land which are required for residential development.

A substantial area east and west of the freeway extension from Bartrum Road to Rowley Road has been identified as land that can become residential.

A major amendment to the Metropolitan Region Scheme is currently being advertised for public comment by the State Planning Commission.

The amendments include land within the City of Cockburn, the Town of Kwinana and the Shire of Serpentine-Jarrahdale.

The plan earmarks land for future urban development in the Jandakot/Mandogalup area adjacent to the planned southern extension of the Kwinana Freeway.

The amendment proposes rezoning 1,675 hectares of land from Rural to Urban and Urban Deferred. This land will have the potential to create 15,075 residential lots with an estimated population of 45,225 people.

The amendment also proposes to rezone the Jandakot special industrial area from



Special Industrial to Industrial in accordance with the recommendations for the Jandakot Iand Use and Water Management Strategy.

In addition, the amendment reserves 2,250 hectares as parks and recreation for the Jandakot Botanic Park and the Jandakot major sporting complex.

Reservations are also proposed for important regional roads, controlled access highway, public purposes and for the South West Corridor public transport route.

The South West Corridor public transport route is designed to accommodate a future rapid transport system linking Mandurah, Rockingham, Kwinana and Perth via Jandakot and Kenwick. Through Jandakot, the route runs within or adjacent to the existing Kwinana freeway reserve.

# CANBERRA'S PRESENT TO COOLBELLUP IS NOW OPEN

THE first public library at Coolbellup was established in 1989 in a small, recycled kindergarten building.

This building was extended in a minor way and renovated by Council's building maintenance staff.

It opened to the public in November 1989. The stock of 10,000 items, plus our local material, was somehow squeezed in, leaving little space for anything else.

While it had disadvantages, it was all we had, and given the general state of affairs it seemed unlikely that we would get anything better.

It was decided to concentrate our energies on good service and promoting the development of libraries in other localities throughout the city.

But, out of the blue in August 1992, the Federal government announced funding proposals for capital works projects of worthwhile and lasting community value.

Cockburn found itself looking at a potential 'gift' of \$1.9million. It was clearly too good an opportunity to let pass and quick action

was required because work had to start by December 3. Spend it or lose it, were the options.

A brainstorming session of key staff came up with 40 possible projects. The following weeks saw hurried activity as the list was pared and fine-tuned. Council approvals were obtained and money shuffled around to match requirements.

Finally, when proposals went to the Minister in Canberra, the Centenary Hall Community Centre project was one of eight approved.

The project consisted of a new library, office and training areas for Skillshare, and the conversion of the previous library (old kindergarten building) into a resource centre for a number of community groups.

Council appointed the Fremantle architect Murray Slavin to the project. The library, on a prominent corner site, was given a light, airy, welcoming and functional treatment. Two sides are essentially glass walls which give continuity with the environment and strong identification of the building's purpose.

Moving the contents of one building to

purposes. A competition for a regional logo and slogan produced "The Growth Zone" and a stylized emblem representing a stairway to growth.

The new logo has been erected at two Cockburn locations to welcome visitors to the Growth Zone.

# COUNCILLOR: WE MUST NOT GIVE IN TO THE VANDALS

WEST Ward Councillor Marinko Pecotic has answered residents who have called for pedestrian accessways to be closed as a means of halting anti-social behaviour by an irresponsible few.

Mr Pecotic says the accessways commonly known as walkways or pathways — must stay open for the common good. He said:

"Accessways are designed as a short cut to reach schools, transport and community services in the area.

"The accessways are primarily used by children walking to and from school and elderly people who cannot manage the extra long walk to the shop, or to the bus-stop.

"The pedestrian accessways have become a problem because they are being used by irresponsible individuals for activities for which they were never designed.

"At night these narrow corridors separating houses have become a haven for people engaging in activities such as alcohol and drug abuse, vandalism and raucous behaviour.

"Residents whose properties border on accessways have, naturally, been seriously offended by such behaviour and want something done about it.

"Residents who are vandalised and scandalised by these individuals have been very vocal in demanding that the accessways are blocked off. This solution has been applied by the council in a number of instances. "Although I sympathise with residents who are directly affected, to take this benefit away is inconsiderate and unfair.

"Why should people in the neighbourhood suffer because of the actions of irresponsible hooligans?

"When vandalism and disturbances occur at schools or community centres, are they closed down? Of course not.

"Accordingly, it is a ludicrous proposal to block off pedestrain accessways. Shutting down accessways is a simplistic solution to a complex problem which is merely transferred to the next pedestrian accessway until that one, too, is shut down.

"A number of solutions to this problem come to mind. Better street and accessway lighting, and regular police or security patrols would make these places less attractive for these individuals.

"A local education campaign conducted through the schools would certainly place accessways and their designed use in the spotlight.

"Last but not least, parents have to be aware of their children's activities and must try to bring their children's behaviour to the acceptable community standard.

"I do not support the closure of pedestrian accessways. It is a community issue and everyone needs to accept that they are part of the solution."

# TAKE THE JET ROUTE TO A NEW CAREER

JOB education and training (usually known as JET) and Family Day Care have made a big difference to the lives of Binday and her son Pardeep.

Binday, a sole parent, decided recently to try to get back into the workforce, but she was worried about who would look after Pardeep.

When she had a chat with staff of the City of Cockburn Family Day Care scheme she found that they could organise flexible child care for Pardeep, including before-school and after-school, as well as holiday care.

This meant that Binday could go to work knowing that her son was secure and happy. Just as importantly, they were able to tell her about the JET advisor at the Fremantle office of the Department of Social Security who could help her with subsidies on the child care fees and information on educational and training courses.

When Binday met the JET

advisor she was pleased to find that many choices were open to her. Through the Commonwealth Employment Service (CES) she could participate in community/activity courses, training courses offered by CES and Skillshare, Technical and Further Education (TAFE) courses, or Year 10 to Year 12 studies if she wanted to prepare for tertiary entrance.

Binday decided to study an office and secretarial course with Melville Skillshare, and after completing the course she took advantage of the word processors at Skillshare which can be used for the preparation of work resumes and job applications.

Binday obtained several job interviews, and last month she completed a two-week training programme at Sir Charles Gairdner Hospital so she now hopes to be employed in casual shift work.

Binday plans to continue her studies to improve her employment prospects, and will take a medical terminology course. During all this time the City of Cockburn Family Day Care Scheme has been able to provide reliable child care for Pardeep.

> Sole parents on full or parttime pension's have a hard enough time without the difficulties associated with further studying or training. This is why three Federal government departments (Dept of Employment, Education and Training; Dept. of Social Security, and Dept of Health, Housing, Local Government and Community Services) together

offer the JET scheme, which combines job and training opportunities with childcare support.

JET and Family Day Care have opened new opportunties for Binday and Pardeep. THE CITY of Cockburn recently budgeted \$10,000 to hold a community fair, the aims of which are to provide an inexpensive family day out, and to promote a feeling of togetherness in the community.

The fair will be held in Manning Park, Spearwood, on Saturday, February 26 (12pm-10pm) and Sunday February 27 (10am-3pm).

Many local businesses and community groups will have stalls and displays at the fair, which will showcase the wide variety of services Cockburn has to offer.

There will be varied entertainment on stage, including a fashion parade provided by the Phoenix Shopping Centre, aerobic displays, local entertainers and much more. Horse and camel rides, helicopter flights and showrides will add to the appeal of the weekend's festivities.

The Lotteries Commission has sponsored an outdoor family concert, starting at 7pm on Saturday evening on the grassed area in front of the park's music shell. The concert will feature entertainment by local talent and will be followed by a grand firework display generously provided by St Paul's Estate.

want to picnic on the grass. Demonstrations and displays will continue on Sunday, culminating in a charity auction at 3pm. Many local businesses and individuals have donated large and small items for auction, so come along and join the bidding excitement.

# RUBBISH COLLECTION TO GO

THE City of Cockburn's new side-loading, high-tech refuse collection vehicles will provide safer working conditions for council employees. They will also create a new category of skilled worker.

Tenders for three of the new trucks were accepted by Council in December and the first of them will be delivered in time for residents to see it on the road in June/July 1994.

Refuse collectors have long been recognised as having one of the most dangerous occupations.

Operating traditional trucks, they risk being attacked by dogs, being hit by passing vehicles, falling over accidently and being injured by swift-moving machinery as they collect some 70 tonnes of rubbish in the City of Cockburn each day.

The increased safety features for collectors in the new trucks will lead to cost savings because there will be fewer accidents.

The collector will no longer be an unskilled worker — he or she will become a high-tech machine operator.

The trucks revolutionise the collection of domestic waste by using an automated loading

HIGH-TECH arm to pick up and empty 240-litre wheeled

arm to pick up and empty 240-litre wheeled bins into the collection truck's hopper without requiring the operator to leave the vehicle cabin.

This allows the vehicle to operate with a crew of one. The driver controls the fullyautomated pick-up, emptying and replacement of the bins with an electronic joystick in a dual-control cabin. A video camera allows a full view of the operation.

The automated arm can pick up a bin within about two metres provided it has been placed on the verge the correct way, which requires the hinge to be facing away from the roadside

The truck's hopper and compacter are also operated from within the cabin.

The system is safer than the current operation because:

- \* It is operated from the left-hand kerb side of the road during pickup, and
- \* It does not require collectors to zig-zag across roads to collect bins from both sides
- The operator does not have to manually move overweight bins.
